There is a strong symbiosis of the Guardians and the Gardener of Governance[™] (Lenz 2021), both aspiring to the long-term health of their organization, seeking to prevent governance failure.

Course objective

Understand GOVERNANCE as the overarching concept.

Discover the significance of directors and senior managers as the GUARDIANS of an organization, the heart, mind, soul, and conscience.

Explore the role of effective Internal Auditors as THE GARDENER OF GOVERNANCE.

Gain firsthand insights, conceptual and hands-on guidance into a creative perspective on positioning the effective internal auditor in the Governance Ecosystem.

Program

This training is designed to strengthen the leadership role of internal auditing in governance, with a focus on developing high-impact teams, fostering strategic relationships with key stakeholders, and embedding aligned assurance to prevent governance failures. The agenda is structured around the following themes:

- Status quo vs. Vision 2035 starting from misalignment and redefining direction
- Securing the "buy-in" of internal audit teams for a strategic governance mission
- Developing high-impact internal audit teams through leadership and influence
- From oversight to cultivation internal auditors as "Guardians and Gardeners" of governance
- Building strategic relationships with management, Audit Committee, and the Board
- Nurturing trust-based relations with the Central Bank and other regulators
- Preventing governance failures through aligned assurance and collaborative leadership
- Practical steps for embedding leadership in modern and effective internal auditing.

Instructor Bio



Dr. Rainer Lenz is a distinguished finance and corporate audit executive with over 30 years of international experience in leading global organizations. He is a *Bankkaufmann* (Qualified Banker) from Sparkasse and holds a PhD in Economics and Management Science from the Louvain School of Management in Belgium. Throughout his career, Dr. Lenz has been recognized for his thought leadership, earning multiple industry awards, including the 2023 Bradford Cadmus Memorial Award from the Global Institute of Internal Auditors.

Dr. Lenz is the co-author of *The Gardener of Governance: A Call to Action for Effective Internal Auditing*, published by Taylor &

Francis in 2025. In this seminal work, co-authored with Barrie Enslin, both build on The Gardener of Governance™ (Lenz 2021) metaphor, positioning internal auditors as cultivators of ethical and sustainable organizational practices. The book emphasizes a shift from traditional compliance-based roles to a more strategic, value-driven approach, advocating for the integration of the "5 Ps" framework - People, Public, Performance, Purpose, and Planet - into internal auditing practices.

In addition to his executive roles, Dr. Lenz serves as an independent board member and as a university lecturer specializing in corporate governance and internal auditing. His career reflects a commitment to advancing the standards of corporate accountability and organizational performance through both practice and education.
